Child Protection Policy (POCSO-Protection of Children from Sexual Offences)

We at DAV Public School, Uppal's Southend, sector-49, Gurugram, recognize that all children, regardless of age, disability, gender, racial heritage, religious belief, sexual orientation or identity, have a right to equal protection from all types of harm or abuse.

Our school believes that a child or young person should never experience abuse of any kind. We have a responsibility to promote the welfare of all children and young people and to keep them safe. We are committed to practice in a way that protects them.

We will seek to keep children and young people safe by:

- Provide an enabling environment for children's, physical, social, emotional, moral and intellectual development
- Valuing them, listening to and respecting them
- Be inclusive and involve all children without selection or exclusion on the basis of gender, disability, ethnicity, religion or any other status.
- Adopting child protection practices through procedures and a code of conduct for staff and volunteers
- Develop special measures/supervision to protect younger and especially vulnerable children from peer and adult abuse
- Providing effective management for staff and volunteers through supervision, support and training
- Sharing information about child protection and good practice with children, parents, staff and volunteers
- Develop clear rules to address specific physical safety issues in the school campus
- Sharing concerns with agencies who need to know, and involving parents and children appropriately.
- Report suspected or alleged abuse to the designated committee.
- Be aware of high-risk peer situations (e.g. unsupervised mixing of older and younger children and possibilities of bullying at various places in school campus
- Encourage and respect children's voices and views.
